City Manager report

City manager McLaughlin did not have anything to report. She is looking for guidance from council on how they would like to proceed with the upkeep of Salt Creek campground. The city does not have the resources to keep up with all 21 sites. Would council like to keep 5 or 10 sites and allow the rest to return to nature? Mayor Testory stated that Salt Creek campsites started as a volunteer mission but interest has since waned. There was some discussion open to reducing the number of sites and marketing the camp better.

A. Approval of LOI between the City of Farmer City and Tabeling Development Company. MOTION by Walsh, seconded by Friedrich, to remove the approval of the LOI between the City of Farmer City and Tabeling Development Corporation from the table. Voting yes: Testory, Friedrich, Walsh and Strough. Motion carried.

This LOI concerns the 20-acre property at the NW corner of I74 and Rt. 54. TDC intends to begin construction in the spring on two 8-unit apartment buildings and six duplex units. It calls for TIF assistance for all TIF eligible expenses as well as the City providing utilities and reimbursement for construction of the access road. Staff and Tabeling will then work out further details in a development agreement if the LOI is approved.

Shawn and Austin Tabeling were in attendance to answer any questions council may have concerning the development. They want to assure council that they are invested in the long term with this project. Council would still like to see a capped amount included in the final numbers. Attorney Joe Chamley reminded council that a letter of intent is not binding and they could move forward with approval and insert a capped amount in the final paperwork.

MOTION by McKinley, seconded by Friedrich, to amend the approval of LOI between the City of Farmer City and Tabeling Development Company to include "TBD" in 2 places on page 2 of the LOI. Voted unanimously. Motion carried.

MOTION by Friedrich, seconded by Walsh, to approve as amended the LOI between the City of Farmer City and Tabeling Development Company. Voted unanimously. Motion carried.

RE: Insurance

It is time to renew our insurance. IMLRMA, which is our current carrier, is recommending no increase to our Min/Max coverage for 2024.

We paid \$119,861 for 2023 for paying early (the regular premium is \$121,069) and the max is \$164,363.

The rates will be identical for 2023, which would be \$121,069 minimum to \$164,363 maximum. If we pay by November 17, 2023, we receive a 1% reduction, so it would be \$119,860.81.

Therefore, I recommend approving a renewal with IMRMA for \$119,860.81.

Ordinance No. 1103

AN ORDINANCE AUTHORIZING THE EXECUTION OF THE RMA MINIMUM/MAXIMUM CONTRIBUTION AGREEMENT

Whereas, the City of Farmer City, a member in good standing of the Illinois Municipal League Risk Management Association (RMA) and party to the RMA Intergovernmental Cooperation Contract, has been fully apprised of the RMA Minimum/Maximum Contribution Agreement which amends and supplements the RMA Declarations pages dated 01/01/24 to 01/01/2025 and all endorsements thereto; and

Whereas, the City Council of the City of Farmer City finds it to be in the best interest of the municipality to make its RMA contribution in accordance with the RMA Minimum/Maximum Contribution Agreement; and

- **NOW, Therefore,** be it ordained by the Mayor and City Council of the City of Farmer City as follows, to-wit:
- **Section 1.** That the execution of the RMA Minimum/Maximum Contribution Agreement for a one (1) year period beginning 01/01/2024 and ending 01/01/2025 is hereby authorized.
- Section 2. That the Mayor and City Manager are hereby granted authority to execute the RMA Minimum/Maximum Agreement which amends and supplements the RMA Declarations pages dated 01/01/2024 to 01/01/2025 and all endorsements thereto.
- <u>Section 3.</u> <u>Effective Date</u>. The provisions of this Ordinance shall become effective immediately following its passage, approval and publication as required by law.
- <u>Section 4.</u> Conflict. All other ordinances or parts of ordinances which are in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby superseded.
- Section 5. <u>Publication</u>. The City Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form immediately after passage.

RE: Ordinance Amendment for vapes

On April 19, 2023, our SRO King went before the school board and presented a Juvenile Diversion Program that was approved by board members due to the amount of vaping/smoking incidents. It's becoming easier and easier to buy Vapes. Staff is recommending an update to our ordinance regulating the possession of Tobacco and alternative Nicotine Products by minors. Currently the age is 18 but police believe it should be 21 to meet the state's minimum age to purchase/possess nicotine, cannabis, and alcohol products.

There was an incident at school last year with a juvenile male who had alcohol, vape, and cannabis on him. The essence of updating and adding to the city ordinances specifically for those under the age of 21 is to keep the children from having a criminal background.

Below is the graph indicating instances of the use of vapes and cannabis. Therefore, we recommend amending the ordinance prohibiting this use from 18 to 21 years of age.

Ordinance No. 1104

An Ordinance Amending Chapter 136: Offenses Against Public Health and Safety

Whereas, the City of Farmer City desires to reduce cannabis, illegal drug, alcohol, tobacco and nicotine use by persons under the age of twenty-one (21); and

NOW, Therefore, be it ordained by the Mayor and City Council of the City of Farmer City as follows, to-wit:

<u>Section 1</u>. Section 136.08, entitled "POSSESSION OF TOBACCO AND ALTERNATIVE NICOTINE PRODUCTS BY MINORS PROHIBITED" of Chapter 136, entitled "OFFENSES AGAINST PUBLIC HEALTH AND SAFETY", of the Farmer City Code, is amended to read as set forth below:

§ 136.08 - Possession of Tobacco and Alternative Nicotine Products by Minors Prohibited.

- (A) <u>Generally</u>. It shall be unlawful for any person under the age of twenty-one (21) years to possess any tobacco products or alternative nicotine products; provided that the possession by a person under the age of twenty-one (21) years under the direct supervision of the parent or guardian of such person in the privacy of the parent's or guardian's home shall not be prohibited.
- (B) <u>Definition of Tobacco Products</u>. Tobacco products is defined as: any substances containing tobacco leaf, including, but not limited to, cigarettes, cigars, pipe tobacco, snuff or smokeless tobaccos including chewing tobacco and dipping tobacco.
- (C) <u>Definition of Alternative Nicotine Product</u>. Alternative Nicotine Product is defined as: a product or device not consisting of or containing tobacco that provides for the ingestion into the body of nicotine, by chewing, smoking, absorbing, dissolving, inhaling, snorting, sniffing or otherwise. "Alternative nicotine product" excludes cigarettes, smokeless tobacco or other tobacco products, as these terms are defined under state law and any product approved by the U.S. FDA as a non-tobacco product for sale as a tobacco cessation or dependence product or for other medical purposes and is marketed and sold solely for that purpose.
- (D) <u>Penalty.</u> Any person 13 years of age or older who violates any provision of this Section shall be subject to a penalty of no more than \$100 or community service or both, for each such violation. If the violator is under 13 years of age, the parent or custodian of the violator is subject to the fine or community service, or both, for each such violation.

Section 2. Section 136.09, entitled "POSSESSION OF CANNABIS PROHIBITED" of Chapter 136, entitled "OFFENSES AGAINST PUBLIC HEALTH AND SAFETY", of the Farmer City Code, is added to read as set forth below:

§ 136.09 - Possession of Cannabis Prohibited.

- (E) <u>Generally</u>. It shall be unlawful for any person under the age of twenty-one (21) years to possess any substance containing cannabis.
- (F) <u>Definition of Cannabis</u>. For the purpose of this section, cannabis includes any substance defined as "cannabis" in the Illinois Cannabis Control Act, ILCS Ch. 720, Act 550, § 3.
- (G) <u>Penalty</u>. Any person who violates any provisions of this section shall be fined not less than \$100 nor more than \$750.

Section 3. Section 136.10, entitled "POSSESSION OF DRUG PARAPHERNALIA PROHIBITED" of Chapter 136, entitled "OFFENSES AGAINST PUBLIC HEALTH AND SAFETY", of the Farmer City Code, is added to read as set forth below:

§ 136.10 - Possession of Drug Paraphernalia Prohibited.

- (A) <u>Generally</u>. Other than as allowed under state law, it shall be unlawful for any person to knowingly possess within the corporate limits of the city any item of drug paraphernalia with the intent to use it for the purpose of unlawfully ingesting, inhaling or otherwise introducing cannabis or a controlled substance into the human body.
- (B) <u>Definitions</u>. Definitions. As used in this section, the following terms shall include and have the following meanings:

CANNABIS. Includes any substance defined as "cannabis" in the Illinois Cannabis Control Act, ILCS Ch. 720, Act 550, § 3.

CONTROLLED SUBSTANCE. Includes any substance defined as a controlled substance in the Illinois Controlled Substances Act, ILCS Ch. 720, Act 570, §§ 201 et seq.

DRUG PARAPHERNALIA. Any object or device used, designed for use or intended for use in unlawfully ingesting, smoking, administering, or storing cannabis or a controlled substance. For the purposes of this section, DRUG PARAPHERNALIA includes but is not limited to:

- (a) Metal, wooden, plastic, glass, stone or ceramic pipes, with or without screens;
- (b) Water pipes;

- (c) Carburetion tubes and devices;
- (d) Smoking and carburetion masks;
- (e) Roach clips;
- (f) Cocaine spoons and vials;
- (g) Bongs; and
- (h) One-hitters.
- (C) <u>Penalty</u>. Any person who violates any provisions of this section shall be fined not less than \$100 nor more than \$750.
- (D) Forfeiture. Drug paraphernalia as defined herein, seized by police officers pursuant to an arrest or issuance of a notice to appear for a violation of this section, shall be forfeited to the city upon a conviction for violation of this section, or upon payment of a minimum fine in settlement of the violation.

Section 4. Section 136.11, entitled "POSSESSION OF ALCOHOL BY PERSON UNDER THE AGE OF 21 PROHIBITED" of Chapter 136, entitled "OFFENSES AGAINST PUBLIC HEALTH AND SAFETY", of the Farmer City Code, is added to read as set forth below:

§ 136.11 - Possession of Alcohol by Person Under the Age of 21 Prohibited.

- (A) <u>Generally</u>. It shall be unlawful for any person under the age of twenty-one (21) years to possess or consume any alcoholic beverage, except for the possession or consumption in the performance of a religious service or ceremony, or under the direct supervision and approval of a parent or guardian in the privacy of their home.
- (B) <u>Penalty</u>. Any person who violates any provisions of this section shall be fined not less than \$100 nor more than \$750.
- <u>Section 5.</u> <u>Effective Date</u>. The provisions of this Ordinance shall become effective ten (10) days following its passage, approval and publication as required by law.
- **Section 6.** Conflict. All other ordinances or parts of ordinances which are in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby superseded.

<u>Section 7.</u> <u>Publication</u>. The City Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form immediately after passage.

RE: Liquor license renewals

Currently, liquor license renewals must be processed every 6 months (April 30 and October 31) every year. Multiple licensees have requested the ability to renew annually, most likely because its easier in terms of paperwork.

The Mayor and staff have no issue with this request and hereby recommend amending the code per the attached proposed ordinance. The Mayor also requested the ability to require a licensee to renew every 6 months if found to be in violation of any law or ordinance.

If the Council approves this amendment, staff will also revise the application by creating two applications, one for annual renewals and one for 6y month renewals. Thank you.

ORDINANCE 1106

AN ORDINANCE AMENDING CHAPTER 110, SECTION 17(B) OF THE CODE OF ORDINANCES

WHEREAS, the City of Farmer City is an Illinois municipal corporation, organized and operating pursuant to the laws and constitution of the State of Illinois; and

WHEREAS, the City requires licenses to sell alcohol within the city limits;

WHEREAS, the City has determined it to be in the best interests of the City and licensees to amend the liquor code to allow for annual license renewals;

NOW, THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of Farmer City, DeWitt County, Illinois, that:

<u>Section 1</u>. Chapter 110, Section 17(B) is hereby amended, to read as follows:

All licenses issued under the provisions of this chapter shall terminate on the 30th day of April. Licensees may choose to renew in 6-month intervals ending on the 31st day of October and again on the following 30th day of April. A license may be issued for the remainder thereof if issued between either of those dates and there shall be a proportionate reduction of the license fee. A license shall also be subject to termination by the Local Liquor Control Commissioner, upon the discontinuation of active, regular business by the licensee. All license fees are payable at the time the application is submitted, whether annually or semi-annually. If the Mayor has authority and basis to suspend or revoke a license, Mayor may require the license be subject to six-month renewal, in addition to any other authorized sanction or penalty.

- Section 2. Should any section or provision of this Ordinance be declared to be invalid, that decision shall not affect the validity of this Ordinance as a whole or any part thereof, other than the part so declared to be invalid.
- <u>Section 3.</u> <u>Effective Date</u>. The provisions of this Ordinance shall become effective immediately following its passage, approval and publication as required by law.
- <u>Section 4.</u> Conflict. All other ordinances or parts of ordinances which are in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby superseded.
- <u>Section 5.</u> <u>Publication</u>. The City Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form immediately after passage.

AN ORDINANCE

<u>DECLARING 20 ACRES (MORE OR LESS) OF FARMLAND AS SURPLUS PROPERTY</u> <u>AND DIRECTING THE SALE OF REAL ESTATE AND RELATED MATTERS</u> (North of I-74, west of East Clinton Avenue/Route 54, Farmer City, Illinois 61842)

WHEREAS, the City of Farmer City, DeWitt County, Illinois (the "City") has the power and authority under and pursuant to Division 76 of the Illinois Municipal Code (65 ILCS 5/11-76-1 et seq.) and also the Tax Increment Allocation Redevelopment Act (65 ILCS 5/11-74.4-4(c) et seq.), as supplemented and amended (collectively, the "Act"); to convey real estate when, in the opinion of the Mayor and City Council (the "Corporate Authorities") of the City, such real estate is no longer necessary, appropriate, required for the use of, profitable to, or for the best interests of the City or if conveyance is reasonably necessary to achieve the objectives of the redevelopment plan for the Farmer City Forward Project Redevelopment Area; and

WHEREAS, the Corporate Authorities now desire to provide direction for a sale of the Real Estate under and pursuant to the provisions of the Act. The Real Estate may be sold as one parcel or as multiple parcels.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FARMER CITY, DEWITT COUNTY, ILLINOIS, as follows:

<u>Section 1</u>. <u>Findings</u>. The Corporate Authorities of the City hereby expressly find and determine that the Real Estate is no longer necessary, appropriate, required for the use of, profitable to, or for the best interests of the City to retain and conveyance is reasonably necessary to achieve the objectives of the redevelopment plan for the Farmer City Forward Project Redevelopment Area.

Section 2. Location, Use and Conditions for the Real Estate. The Real Estate consists of 20 acres (more or less) of farmland with irregular dimensions, generally located north of Interstate 74 and immediately west of East Clinton Avenue/Route 54, Farmer City, Illinois 61842. The Real Estate is not improved with any structure. Conditions of sale of some or all of Real Estate: The Real Estate may be sold as one parcel or as multiple parcels. The first publication of such notice shall be no less than thirty (30) days before December 18, 2023, the date of the regular meeting of the Corporate Authorities at which any such sealed bids will be considered and opened. Such notice shall advertise for sealed bids in connection with the proposed sale of the Real Estate, shall contain the terms of sale and proposed development plan. The City Clerk shall give such notice in accordance with the provisions of this Section 4 of this Ordinance in substantially the form of such notice as is set forth on Exhibit B attached hereto and hereby incorporated herein by this reference thereto.

Section 4. Ratification and Supplemental Authority. All actions of the officers, employees and agents of the City heretofore taken in connection with the proposed sale of the Real Estate are hereby ratified, confirmed and approved. From and after the effective date of this Ordinance, the proper officers, employees and agents of the City are hereby further authorized, empowered and directed to do all such acts and things as may be necessary to accomplish the purposes of this Ordinance in accordance with the applicable provisions of the Act.

<u>Section 5</u>. <u>Effective Date</u>. This Ordinance shall become effective upon its passage and approval as required by law.

We issued a bid for a digital sign to 8 local sign companies as well as posted it on Facebook and our website. We only received one bid, from Bendsen Signs out of Decatur. I did speak with Genoptics, which did the sign in Downs and they wanted to submit but didn't make the deadline.

Bendsen is offering 2 different design ideas for double-sided or single-sided screens and a single post or double post set-up. Please see the attached bid.

The lowest cost in the bid for a double sided is \$70,692 with a single post option. The lowest option overall is a single-sided sign with a single post and smaller screen for \$52,088.

We budgeted \$60,000 this fiscal year based on quotes we received. While I prefer the double-post, in order to get the best set-up within financial reason, I would recommend the double-sided with single post for \$70,692 unless you wish to reject this bid and start over.


