- J. Ordinance 1115 approving the vacation of ROW between Van Buren and Rt. 150 to Scott and Janet Whitehouse.
 - Scott and Janet Whitehouse would like the city to vacate an alley that runs behind their house and between the 3 properties that they own in order to put a fence up. The city is agreeing to this vacation and is asking the homeowners to obtain a formal vacation plat done by a licensed surveyor. Once the city receives the plat, it will be submitted to the county for recording.

 MOTION by McKinley, seconded by Friedrich, to amend ordinance 1115 approving the vacation of ROW between Van Buren and Rt. 150 to Scott and Janet Whitehouse to be subject to the receipt of a formal vacation plat provided by the homeowners. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.
 - **MOTION** by McKinley, seconded by Friedrich, to approve ordinance 1115 approving the vacation of ROW between Van Buren and Rt. 150 to Scott and Janet Whitehouse as amended. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.
- A. Approve change order request #4 to Building Systems to increase the street garage construction bid by \$1436.00.
 - This change allows for Nicor to bore the gas line under a large pile of bricks at the street garage. **MOTION** by McKinley, seconded by Friedrich, to approve change order request #4 to Building Systems to increase the street garage construction bid by \$1436.00. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.
- B. Approve payout request #4 to Building Systems in the amount of \$215,541.00.

The street garage is nearing completion. The hope is that it is done by the end of April and that an open house can be planned in May.

MOTION by McKinley, seconded by Friedrich, to approve payout request #4 to Building Systems in the amount of \$215,541.00. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.

- C. Discussion regarding use of South Park by Farmer City Haunted Forest. Angela Testory, on behalf of The Farmer City Haunted Forest committee, submitted a letter to council requesting the use of South Park for 4 weekends in October. They are adding 2 weekends to account for weather related issues. Council is in agreement that they may use South Park all 4 weekends.
- D. Discussion regarding sunflowers on the square. The 4H Cloverbuds had reached out to City manager McLaughlin asking for the continued use of city property to plant sunflowers. They will be using seedlings this year. Council is in agreement that they may again use this area.
- E. Ordinance 1113 an ordinance amending Chapter 51 Section 51.057 (C) of the City of Farmer City code of ordinances, entitled permit fees.
 - Ordinance 1113 (sewer) and Ordinance 1114 (water) are designed to increase current tap on fees. Sewer will raise from \$250 to \$500 and water will be raised from \$500 to \$750. The current rates do not cover the costs of materials from the city.
 - **MOTION** by McKinley, seconded by Friedrich, to approve Ordinance 1113 an ordinance amending Chapter 51 Section 51.057 (C) of the City of Farmer City code of ordinances, entitled permit fees. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.
- F. Ordinance 1114 an ordinance amending Chapter 51 Section 51.123 (C) of the City of Farmer City code of ordinances, entitled permit fees.
 - **MOTION** by McKinley, seconded by Friedrich, to approve Ordinance 1114 an ordinance amending Chapter 51 Section 51.123 (C) of the City of Farmer City code of ordinances, entitled permit fees. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.
- G. Discussion regarding adding Chapter 38: Zoning Commission
 Farmer City zoning is currently controlled by DeWitt County. Council is being asked if they want to control their own zoning. The city would need to form a zoning commission who would prepare a draft proposed zoning ordinance to city council. The commission would be appointed by the mayor. This would allow Farmer City the control of their own zoning. An ordinance will be brought before council at the next council meeting.
- H. Approval of a Development Agreement with Tabeling Development Company. Per attorney Chamley, a resolution will need to be brought before council at a future meeting but council can act on the development agreement that was brought before them. The agreement has been broken down to 2 sections: phase 1 and phase 2. This current agreement adds language prohibiting lewd businesses and caps phase 1 at 1.5 million dollars. Tabeling Development hopes to turn dirt this fall.
 - **MOTION** by McKinley, seconded by Friedrich, to approve the development agreement with Tabeling Development Company. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.
- I. Approval of the bid for the Market St Water Main project to Cross Construction for \$197,304.00. The city received 3 bids with Cross Construction being the lowest. This project will update a manhole cover, culvert, replace lead water lines and update a part of the city's oldest water main.

MOTION by McKinley, seconded by Friedrich, to approve the bid for the Market St Water Main project to Cross Construction for \$197,304.00. Voting yes: Friedrich, Walsh, McKinley and Testory. Motion carried.

Dear Sue,

Under the Illinois Municipal Electric Agency's ("IMEA's") current Power Sales Contracts and Capacity Purchase Agreements, IMEA has provided the City of Farmer City with reliable, affordable, and sustainable—and more importantly, stable—power and energy needs for several decades. The current Power Sales Contracts and Capacity Purchase Agreements are set to expire on September 30, 2035. In order to plan for and ensure that resources are in place to continue meeting your community's long- and short-term power and energy needs at favorable prices and to continue meeting the obligations imposed on Farmer City as a load serving entity by the Regional Transmission Organization that controls the region where your community is located, IMEA is requesting that Farmer City and its other Participating Members continue their relationship as all-requirements purchasers from IMEA beyond September 30, 2035, by approving and executing new Power Sales Contracts and new Capacity Purchase Agreements with IMEA.

To that end, and pursuant to the IMEA Board of Director's approval of the form of the new contracts at the meeting held on February 15, 2024, enclosed are two (2) originals of the new Power Sales Contract and Capacity Purchase Agreement with IMEA for the City that reflect IMEA's continued commitment to supply Farmer City's power and energy needs. The new Power Sales Contract is for the delivery period of October 1, 2035 through May 31, 2055. IMEA requests that the new contracts be executed by the City of Farmer City through signature by Farmer City's Mayor after approval by the City Council. The terms and conditions of these contracts, as provided, shall be available through May 31, 2025. In order to determine the amount of resources needed to serve the loads of all Participating Members during the future delivery period, the IMEA Board of Directors has authorized holding the offer of these new contracts open through May 31, 2025. These new contracts will not be offered beyond that date without further authorization from the IMEA Board of Directors.

Please return the signed documents and a copy of the Ordinance adopted to approve the contracts to IMEA's office using a courier service that offers tracking information such as FedEx. IMEA will cover the cost of the return service. When you are ready to do so, please contact IMEA's Administrative Assistant, Sarah Cody, at (217) 789-4632, and she can help arrange the return for you. Upon receipt of those documents, IMEA will then seek approval and full execution of the

City's new Power Sales Contract and new Capacity Purchase Agreement at the next IMEA Board of Directors meeting following the City's execution thereof, with the then-fully executed document returned to you for your records. Additionally, please email the approved minutes of the City Council meeting wherein the contracts were approved to thall@imea.org for IMEA's records.

We greatly appreciate the long-term partnership that your community shares with the other participants of IMEA and we look forward to continued success. As always, should you want a representative of IMEA to discuss this with you or your governing body, we will make arrangements to attend an upcoming Council meeting at your request.

Ordinance No. 1116

An Ordinance Adding Chapter 38:	Zoning Commission

WHEREAS, the Mayor and the City Council (the "Corporate Authorities") of the City of Farmer City, DeWitt County, Illinois (the "City") desire to provide for the orderly growth of buildings, homes and infrastructure within the City corporate limits and within the area of 1.5 miles outside of the City corporate limits and to protect the health, safety and welfare of the citizenry of Farmer City; and

WHEREAS, the Corporate Authorities of the City previously adopted a Comprehensive Plan in Ordinance No. 1056 on December 7, 2020; now Section 154.01 of the City Code; and

WHEREAS, creation of a Zoning Commission shall allow for the oversight of development and growth and the protection of the health, safety and welfare of the citizenry of Farm City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FARMER CITY, DEWITT COUNTY, ILLINOIS, as follows:

<u>Section 1.</u> New Chapter 38. Chapter 38, entitled "Zoning Commission", as set forth in Exhibit A to this Ordinance, Sections 38.01 through 38.07, inclusive, is hereby added to the Farmer City Code, "Chapter 38 –Zoning Commission" which is hereby adopted.

<u>Section 2.</u> <u>Invalidity.</u> Should any section or provision of this Ordinance be declared to be invalid, that decision shall not affect the validity of this Ordinance as a whole or any part thereof, other than the part so declared to be invalid.

<u>Section 3.</u> <u>Effective Date</u>. The provisions of this Ordinance shall become effective immediately following its passage, approval and publication as required by law. For any penalty imposed by this Ordinance, said sections shall become effective 10 days following its passage, approval and publication as required by law.

<u>Section 4.</u> Conflict. All other ordinances or parts of ordinances which are in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby superseded.

<u>Section 5.</u> <u>Publication</u>. The City Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form immediately after passage.

CHAPTER 38 -- ZONING COMMISSION

§ 38.01 CREATION.

- (A) There is hereby created a Zoning Commission for the city, which shall consist of five members to be appointed by the Mayor with the review, consent and approval of the City Council.
 - (B) All members shall reside within the city.

§ 38.02 TERM.

The terms of the members of the Zoning Commission shall be one year.

§ 38.03 ORGANIZATION.

The Zoning Commission shall elect its own Chairperson, Vice-Chairperson and other officers as it may deem necessary. The City Manager shall be the Secretary of the Zoning Commission. The City Council may provide technical and other services to the Zoning Commission as may be needed from time to time.

§ 38.04 POWERS.

The Zoning Commission shall have all powers and exercise duties as are provided for in Division 13 of Article 11 of the Illinois Municipal Code, being 65 ILCS 5/1-1-1 et seq. and to exercise those other powers germane to the powers granted by this act, as may be conferred by the City Council.

§ 38.05 RECORDS.

The Zoning Commission shall keep written records of its proceedings which shall be open to inspection by the City Council at all times.

§ 38.06 MEETINGS.

The Zoning Commission shall meet at a time as it may, by majority vote, determine upon as regular meeting dates; or at any time upon call by the Chairperson thereof or by any three members thereof.
